ARTICLE IV BOARD OF DIRECTORS

Section 5

For a Board meeting, the presence of no less than a majority of the Director positions currently filled, at least one of which shall be an officer, shall constitute a quorum. Directors may be present in person, by telephone or through other electronic communications media or any combination thereof so long as all members may simultaneously hear each other and participate during the meeting. A vote of a majority of Director positions present shall constitute the action of the board.

Previous Section 5. For a Board meeting the presence of no less than a majority of Directors, at least one of which shall be an Officer, shall constitute a quorum. Unless a higher vote is specified herein, the vote of most Directors present at a meeting shall constitute the action of the Board. ONLY ONE VOTE <u>PER BOARD POSITION IS ALLOWED.</u>

Article VII Change to read Standing and Special Committees

Special Committees may be appointed by the President or the Board. They are automatically dismissed after the final report of the Committee. They have no voting rights on the Board

Previous Section 4 Special/Ad hoc Committees may be appointed by the President or the Board. They are automatically dismissed after the final report of the Committee. They have no voting rights on the Board

Add Section 5

Standing committees and special committees are authorized to meet in person, by telephone or through other electronic communications media or any combination thereof so long as all members may simultaneously hear each other and participate during the meeting

ARTICLE VIII MEETINGS

Section 4

A quorum for a general, annual or special meeting shall be 20% of the club membership determined by those present <u>in person, by</u> <u>telephone or through other electronic communications media or any combination thereof so long as all members may simultane-</u> <u>ously hear each other and participate during the</u> meeting. Decisions or actions taken or adopted by a majority of the members present and voting shall constitute the action of the club.

Previous Section 4. Decisions or actions taken or adopted by a majority of the members present and voting at a meeting shall constitute the action of the Club.

Our club has completed journey forms for 2022, agreeing to host international and/or domestic ambassadors. Requests for international travel were made for Hungary or Australia/New Zealand. Friendship Force International assignments will be issued by Spring 2021 for these 2022 dates.

Reorganizing for future journeys will take time, effort and enthusiasm. Our club's journey coordinators have been in contact with coordinators from canceled journeys, with hope of rescheduling some of those previously announced journeys.

All these plans will depend on Covid vaccinations, the interest of ambassadors and the overall strength and status of the clubs involved.
